All members should have received an email inviting them to join our new "Last Minute Day Trip and Carpooling" email list (see article above). In your inbox the invitation email would have looked like: "From: noreply@googlegroups.com Subject: Google Groups: You've been invited to Nooksack Nordic Ski Club". The email would have contained a message from Don Hicks describing the nature and intent of this email ListServ. and a link to click-on that would add you to the list if you desired to join. As of December 17, 35 members have done so.

If you did not receive or recognize the invitation email or declined to join, you may at anytime email or call the list manager, Don Hicks, at hicks46@netzero.net, 360-733-4815 and he will add you to the list.

NOTE: YAHOO MAIL will put all email from Google Groups in your SPAM folder! You may find your invitation there and you must hit the NOT SPAM button to receive any further emails from the list in your in-box folder.

The primary purpose of this Email List Server is to facilitate the organization of last minute day trips and carpooling to our home trails near Mt. Baker and other local destinations such as Cypress Mountain, Stevens Pass, Manning Park, etc.. #### DAY TRIP TO HOLLYBURN PLANNED

A day trip to the "Hollyburn" XCski area at Cypress Mountain just north of Vancouver, B.C. is scheduled for Sunday January 23, 2011.

The "Hollyburn" XC-ski area at Cypress Mountain is north of Vancouver, B.C. Only a 1-1/2 hour drive from Bellingham, Hollyburn is our closest premier XC-Ski Park. It has an elevation of 3,500 ft. and 26 km of highly groomed trails for classic and skate skiing that wind past snow-covered lakes, through meadows, and snowy mountain There are fantastic forests. views of the Salish Sea, islands, Burrard Inlet, and the city far There are two huts below. where food can be purchased, one at the entrance and the other (on the trails) is the historic Hollyburn Ski Lodge dating from the 1920's. There is also a large warming hut up the mountain. Trail fees are \$18 (\$12 for 65+) for a full day. We will meet at Sunset Square parking lot, on the Southeast corner at the rock wall, near Cost Cutter at 8am for carpooling.

The first two are "donation requested" with collection boxes on site, with someone to collect your money at Stake Lake. All three are well signed. Skiing is fun at all three, with their different settings and terrain.

For Jerry and me our trip with the club to Highland House, Logan Lake, and Stake Lake was memorable for more than one reason. There were the great accommodations and food, the fun we had at the lodge with fellow club members, the geo-caching, the hot tubing, and of course the skiing.

On this particular trip, Jerry and I did the most skiing at Logan Lake, with a few hours at Stake Lake. This time we did not ski at Kane Valley, though we could have. Each club member who went on this outing has at least one story to tell. Jerry and I have more than one.

Skiing out to the end of Razorhone Road, we admired the views of the North Fork Nooksack River and the peaks across the valley, which were visible through the falling snow. I admired how easy the new snow was to ski, without any ice or rocks to trip us up. If you want to get in some time on your Nordic skis, go to the Crosscountry trails below the Mt. Baker Ski Area. There, you too can experience the severe beauty of winter in the Cascade Mountains, while getting a good workout. I hope to see you there. Keep gliding.
